2008 (20th) REPORT OF THE NOU RECORDS COMMITTEE

The functions and methods of the Nebraska Ornithologists' Union (NOU) Records Committee are described in its bylaws (NOU Records Committee 1986). The committee's purpose is to provide a procedure for documenting unusual bird sightings and to establish a list of all documented birds for Nebraska.

All records mentioned here are available to interested persons at the NOU archives at the University of Nebraska State Museum (UNSM), Lincoln, NE. Interested parties should contact the current NOU Librarian, whose address can be found in the latest issue of The Nebraska Bird Review (NBR).

State List

"The Official List of the Birds of Nebraska" was first published in 1988 (NOU Records Committee 1988) and has been updated two times (NOU Records Committee 1997, 2004). The "Official List" has been appended eighteen times: (Mollhoff 1989; Grenon 1990, 1991; Gubanyi 1996a, 1996b, 1996c; Brogie 1997, 1998, 1999, 2003, 2004, 2005, 2006, 2007, 2008; Jorgensen 2001, 2002, 2003).

The American Ornithologists' Union Checklist of North American Birds, Seventh Edition (1998) and the Forty-second, Forty-third, Forty-fourth, Forty-fifth, Forty-sixth, Forty-seventh, Forty-eighth, and Forty-ninth Supplements to the American Ornithologists' Union (AOU: 2000, 2002, 2003, 2004, 2005, 2006, 2007, 2008) contain many taxonomic changes affecting North American birds.

The following summarizes all 2008 revisions by the AOU in regards to changes in scientific names and changes in assignments to family and order of species to the most recent published "The Official List of the Birds of Nebraska: 2003" (NBR 72: (2004): 108-126).

This report includes all accounts submitted during the 2008 calendar year covering 65 records with accession numbers 1206-1270. One additional record, (Reddish Egret - Keith Co.) was submitted in 2000 (Jorgensen 2002) and was reviewed; but never filed. This record has been assigned an earlier unused accession number (# 873); which corresponds closer to this records original submittal date.

Criteria for Accepted Records

In order for a record to be accepted, a minimum of six votes in favor are required with no more than one dissenting vote (NOU Records Committee 1986). Records in the following classes listed as accepted:

- I-S - a diagnostic, labeled specimen exists
- I-P - a diagnostic, labeled photograph or slide exists
- I-R - a diagnostic, labeled recording exists
- II - three or more independently written diagnostic documentations of the same bird exist
- III - one or two independently written diagnostic documentations of the same bird exist

Each account of an accepted record includes a brief statement noting the species, class, date, location, and initial(s) of observers.

This report summarizes all records accessioned in 2008, discusses any new additions to the state list, and reports any changes in firmness of data of Nebraska birds. Additionally, the list reflects changes in frequency of occurrence, as determined by the NOU Records Committee, which reviewed records of bird occurrences in Nebraska for 1999–2008. Frequency of occurrence is indicated by the following terms (NOU Records Committee 2004):

- Regular - acceptably reported in 9–10 of the past 10 years.
- Casual - acceptably reported in 4–7 of the past 10 years.
- Accidental - acceptably reported in 0–2 of the past 10 years.
- Extirpated - not acceptably reported in the past 50 years.
- Extinct - no longer found alive anywhere in the world.

The frequency of occurrence for any species that is acceptably reported in 3 or 8 of the last 10 years is discussed by the committee and placed in a category felt most appropriate by the committee.

With this report, the following changes are made to “The Official List of the Birds of Nebraska: 2003” .

2008 Additions to State List

There was one new species added in 2008. With this addition, “The Official List of the Birds of Nebraska” now stands at 453 species.

1. Grace's Warbler (*Dendroica graciae*), Accidental, I-P
Insert after: Yellow-throated Warbler (*Dendroica dominica*)

Changes Involving Nebraska Species Due to Taxonomic Revisions and/or Changes in English or Scientific Names

The "black-headed gulls" are split from the genus *Larus*:

1. Laughing Gull (*Larus atricilla*) becomes (*Leucophaeus atricilla*).
2. Franklin's Gull (*Larus pipixcan*) becomes (*Leucophaeus pipixcan*).
3. Little Gull (*Larus minutus*) becomes (*Hydrocoloeus minutus*).
4. Black-headed Gull (*Larus ridibundus*) becomes (*Chroicocephalus ridibundus*).
5. Bonaparte's Gull (*Larus philadelphia*) becomes (*Chroicocephalus philadelphia*).

Changes in Sequence

A change is made in the taxonomic order of the "black-headed gulls" in the "Official List of the Birds of Nebraska". The new sequence is as follows:

Black-legged Kittiwake (*Rissa tridactyla*)
Sabine's Gull (*Xema sabini*)
Bonaparte's Gull (*Chroicocephalus philadelphia*)
Black-headed Gull (*Chroicocephalus ridibundus*)
Little Gull (*Hydrocoloeus minutus*)
Ross's Gull (*Rhodostethia rosea*)
Laughing Gull (*Leucophaeus atricilla*)
Franklin's Gull (*Leucophaeus pipixcan*)

The remaining species of *Larus* are in the same sequence as before.

2008 Changes in Frequency of Occurrence

1. Neotropic Cormorant (*Phalacrocorax brasilianus*) Accidental to Casual
2. Inca Dove (*Columbina inca*) Accidental to Casual
3. Black-throated Gray Warbler (*Dendroica nigrescens*) Accidental to Casual
4. Prairie Warbler (*Dendroica discolor*) Casual to Accidental

2008 Changes in Firmness of Data

1. Black-throated Gray Warbler (*Dendroica nigrescens*) changed from Class III to Class I-P.

Pre-2008 Accepted Records

Mountain Chickadee (*Poecile gambeli*)

1. A single bird was observed (Class III, LH) northwest of Lewellen, Garden Co. ; 30 September, 2007. Accession # 1210
2. A single bird was observed (Class III, SJD) in Harrison, Sioux Co., 28 December, 2007. Accession # 1255

Canyon Wren (*Catherpes mexicanus*)

1. A single bird was observed (Class III, KK) at the hanger of the Sidney Municipal Airport, Cheyenne Co. ; 06-07 October, 2007. Accession # 1269
**It has been over 15 years since the last accepted documentation for this species in Nebraska (Brogie, 1992).

Varied Thrush (*Ixoreus naevius*)

1. An adult male was photographed (Class I-P, DM) at Omaha, Douglas Co. ; 19 December, 2007. Accession # 1207

Pine Warbler (*Dendroica pinus*)

1. A single bird, coming to a suet feeder, was photographed (Class I-P, LB) at North Platte, Lincoln Co. ; 24 December, 2007. Accession # 1206

2008 Accepted Records

Black-bellied Whistling-Duck (*Dendrocygna autumnalis*)

1. A single adult bird was photographed (Class I-P, GS) at Wagon-train Lake, Lancaster Co. ; 21-25 July, 2008. Accession # 1250

Eurasian Wigeon (*Anas penelope*)

1. An adult male was photographed (Class I-P, JJ) at Spikerush WPA, York Co. ; 05 April, 2008. Accession # 1226

Brown Pelican (*Pelecanus occidentalis*)

1. A second-year bird was photographed (Class I-P, KS) at Harlan County Reservoir, Harlan Co. ; 19 October, 2008. Accession 1262

Neotropic Cormorant (*Phalacrocorax brasilianus*)

1. A single bird was photographed (Class I-P, JJ) at Hultline WPA, Clay Co. ; 03 June, 2008. Accession # 1238

Reddish Egret (*Egretta rufescens*)

1. Nebraska's first record for this species; a white morph bird photographed (Class I-P, SJD) at Lake McConaughy, Keith Co. ; 12 October, 2000 was discussed in Jorgensen (2002) but was never filed with an assigned accession number. This record has now been assigned an earlier unused accession number which corresponds closer to this records submittal date (Dinsmore 2001). Accession # 873
2. An adult bird at Funk WPA, Phelps Co. ; 12 June, 2008 was well described (Class III; KS). This represents the second documented record for this species in Nebraska. Accession # 1241

Glossy Ibis (*Plegadis falcinellus*)

1. A lone adult bird was photographed (Class I-P; JJ) at Greenwing WMA, Clay Co., 04 May, 2008. Accession # 1234

White-tailed Kite (*Elanus leucurus*)

1. A single bird was observed (Class III, TJW) on the Brady Breeding Survey Route, Lincoln Co. ; 01 July, 2008. Accession # 1246

Yellow Rail (*Coturnicops noveboracensis*)

1. A single bird was observed (Class III, SJD) at North Kirkpatrick WMA, York Co. ; 15 May, 2008. Accession # 1256

Common Crane (*Grus grus*)

1. A single bird was photographed (Class I-P, ABu) near the Gibbon Bridge, Buffalo Co. ; 06 March, 2008. Accession # 1223
2. Another photograph (Class I-P, ST) of the above bird near the same location taken on 08 March, 2008. Accession # 1222
3. A single bird was photographed (Class I-P, TJW) northeast of Hershey, Lincoln Co. ; 02 April, 2008. This location is approximately 120 miles west of the above sightings and may possibly represent a second bird. Accession # 1225
4. Another series of photographs (Class I-P; DWN) of the bird near Hershey,

Lincoln Co. ; 05 April, 2008. Accession # 1242

Red Knot (*Calidris canutus*)

1. A single bird was photographed (Class I-P, BM) at Funk WPA, Phelps Co. ; 10 May, 2008. Accession # 1237

Jaeger (*Stercorarius*) species

1. A jaeger species, (voted on as such) believed to be an immature Parasitic Jaeger (*Stercorarius parasiticus*) was observed (Class III, DP, JP) at Fort Niobrara NWR, Cherry Co. ; 10 September, 2008. Accession # 1258

Band-tailed Pigeon (*Patagioenas fasciata*)

1. A single adult bird was photographed (Class I-P, DF) at a feeder in Ceresco, Saunders Co., 20 February, 2008. Accession # 1217
2. An additional photograph (Class I-P, DJ) of the above bird taken 23 February, 2008. Accession # 1218
3. An additional photograph (Class I-P, PR) of the above bird taken 23 February, 2008. Accession # 1219
4. An additional photograph (Class I-P, JJ) of the above bird taken 23 February, 2008. Accession # 1220

Inca Dove (*Columbina inca*)

1. A single bird was videotaped (Class I-P, BH) at a feeder in Brule, Keith Co. ; 01 November, 2008. Accession # 1264

Mountain Chickadee (*Poecile gambeli*)

1. A single bird was photographed (Class I-P, TS) south of Ogallala, Keith Co. ; "sometime in February of 2008". Accession # 1224

Bewick's Wren (*Thryomanes bewickii*)

1. A lone bird was observed and carefully described (Class III, CK) at Bellevue, Sarpy Co. ; 02 May, 2008. Accession # 1232

Varied Thrush (*Ixoreus naevius*)

1. An adult male was photographed (Class I-P, CH) at Omaha, Douglas Co. ; 21 April, 2008. Accession # 1229
2. An adult male was photographed (Class I-P, TS) south of Ogallala, Keith Co. ; late November, 2008. Accession # 1270

Bohemian Waxwing (*Bombycilla garrulus*)

1. A group of "20-30 adults" were observed (Class III, BN) at Riverside Zoo,

Scottsbluff, Scotts Bluff Co. ; 13 April, 2008. Accession # 1227

Grace's Warbler (*Dendroica graciae*)

1. A single bird was photographed (Class I-P, CG) at Crescent Lake National Wildlife Refuge, Garden Co. ; 04 May, 2008. Accession # 1233
**This represents the first documented record for this species in Nebraska.

Black-throated Gray Warbler (*Dendroica nigrescens*)

1. An adult male was photographed (Class I-P, SJD) at Crescent Lake National Wildlife Refuge, Garden Co. ; 16 May, 2008. Accession # 1257

Pine Warbler (*Dendroica pinus*)

1. An adult bird was photographed (Class I-P, CaG) at Pioneers Park, Lancaster Co. ; 01 November, 2008. Accession # 1265

Golden-crowned Sparrow (*Zonotrichia atricapilla*)

1. A single adult bird was photographed (Class I-P, CKe) in Creighton, Knox Co. ; 01 May, 2008. Accession # 1230
2. An additional photograph (Class I-P, MAB) of the above bird taken 02 May, 2008. Accession # 1231

Painted Bunting (*Passerina ciris*)

1. An adult male was observed (Class III, PD) at Deweese, Clay Co. ; 12 May, 2008. Accession # 1235
2. A "female or first year male" was observed (Class III, KS) at Kearney, Buffalo Co. ; 14 May, 2008. Accession # 1236

Lesser Goldfinch (*Carduelis psaltria*)

1. A "black-backed" male was photographed (Class I-P, JJ) at Carter Canyon, Scotts Bluff Co. ; 26 August, 2008. Accession # 1253

Unaccepted Records

Records in the following classes are considered unaccepted (NOU Records Committee 1986) :

IV - probably correct, but not beyond reasonable doubt.

V - a record with insufficient evidence to support the identification claimed.

VI - a probable released or escaped bird or mistaken identification.

Each account of an unaccepted record includes a brief statement noting the species,

class, date, location, and reasons for the committee's failure to accept the record.

Unaccepted Records (Received in 2008)

Mute Swan (*Cygnus olor*)

1. Two juvenile Mute Swans were photographed at Wehrspann Lake, Sarpy Co.; 01 November, 2008. The identification of these birds was not in question, however; this species is commonly kept in captivity, and the provenance of these birds was believed to be not determinable. Class VI. Accession # 1263. This species is not on "The Official List of the Birds of Nebraska".

Glossy Ibis (*Plegadis falcinellus*)

1. A bird photographed at North Lake Basin, Seward Co.; 31 July, 2008 was believed to be this species by several observers. The photographic evidence provided was not deemed to be definitive enough to rule out the question of hybridization (Glossy Ibis X White-faced Ibis (*Plegadis chihi*)). Class IV. Accession # 1248
2. A bird photographed at Tamora WPA, Seward Co.; 23 August, 2008 was believed to be this species. The photographic evidence provided was not deemed to be definitive enough to rule out the question of hybridization (Glossy Ibis X White-faced Ibis). Class IV. Accession # 1252

Black Rail (*Laterallus jamaicensis*)

1. A written description of an adult bird observed 26 September, 2008 at Spring Creek Audubon Center, Lancaster Co., was received. Although suggestive, the description lacked sufficient details for approval. Class IV.
Accession # 1259

Monk Parakeet (*Myiopsitta monachus*)

1. A single bird was present in central Omaha, Douglas Co. from 28 September through 02 November, 2008. The bird was photographed on 30 September; and while the identification of this bird is not in question, the provenance of this bird was believed to be not determinable. Class VI. Accession # 1260. This species is not on "The Official List of the Birds of Nebraska".

Dusky Flycatcher (*Empidonax oberholseri*)

1. A single bird was photographed at Oliver Reservoir, Kimball Co.; 08

September, 2007. Although very suggestive, the photograph provided did not conclusively rule out similar species. Class V. Accession # 1214

Black-throated Gray Warbler (*Dendroica nigrescens*)

1. A single bird was photographed at Oliver Reservoir, Kimball Co.; 08 September, 2007. Although very suggestive, the photograph provided did not conclusively rule out similar species. Class V. Accession # 1213

Lesser Goldfinch (*Carduelis psaltria*)

1. A single bird was photographed south of Exit 1, Kimball Co.; 30 August, 2008. Although very suggestive, the photographs provided did not conclusively rule out similar species. Class IV. Accession # 1254

Records Submitted in 2008: Filed Without Votes

Red-breasted Merganser (*Mergus serrator*)

1. A description (KD) of single "probably female" bird in the company of two Hooded Merganser (*Lophodytes cucullatus*) one mile east of Scottsbluff, Scotts Bluff Co., 15 December, 2007 was filed. Accession # 1208

Red-necked Grebe (*Podiceps grisegena*)

1. A photograph (DH) of an adult bird at Lake Ogallala, Keith Co.; 03 September, 2006 was filed. Accession # 1244

Yellow-crowned Night-Heron (*Nyctanassa violacea*)

1. A photograph (DH) of a juvenile bird at Lake Ogallala, Keith Co.; 16 September, 2006 was filed. Accession # 1243
2. Photographs (KS) of an adult bird at Funk WPA; 02 August, 2008 were filed. Accession # 1249
3. Photographs (RW, SW) of a single juvenile bird present from June through the end of August, 2008 in Norfolk, Madison Co. were filed. Accession # 1251

Osprey (*Pandion haliaetus*)

1. A description (KD) of an adult bird observed just west of Haig, Scotts Bluff Co.; 15 December, 2007 was filed. Accession # 1209

Broad-winged Hawk (*Buteo platypterus*)

1. Photographs (RHo via TJW) of an adult bird at a nest with young in North Platte, Lincoln Co.; 03 July, 2008 were filed of this most remarkable

extralimital nesting record of Broad-winged Hawk in Nebraska. Accession # 1247

Mew Gull (*Larus canus*)

1. Photographs (PD) of a second-year bird at the sewage lagoons south of Alma, Harlan Co. ; 29 November, 2008 were filed. Accession # 1268

Sabine's Gull (*Xema sabini*)

1. A photograph (DH) of a juvenile bird at Enders Reservoir, Chase Co. ; 23 September, 2006 was filed. Accession # 1245
2. A photograph (PD) of an adult bird at the sewage lagoons south of Alma, Harlan Co. ; 08 October, 2008 was filed. Accession # 1261

Snowy Owl (*Bubo scandiacus*)

1. A photograph (JJ) of a first-year bird found northeast of Wahoo, Saunders Co. ; 23 February, 2008 was filed. Accession # 1221

Scissor-tailed Flycatcher (*Tyrannus forficatus*)

1. A description (RH) of an immature bird observed north of Milburn Diversion Dam, Blaine Co. ; 01 June, 2008 was filed. Accession # 1239

Pygmy Nuthatch (*Sitta pygmaea*)

1. Photographs (JJ) of an extralimital bird in Lincoln's Pioneers Park Lancaster Co. ; 01 November, 2008 were filed. Accession # 1266

Palm Warbler (*Dendroica palmarum*)

1. A description (RS) of a bird observed near Gering, Scotts Bluff Co. ; 05 November, 2008 was filed. The observer was confident that the bird belonged to the Yellow (Eastern) population (*D. p. hypochrysea*). Accession # 1267

Western Tanager (*Piranga ludoviciana*)

1. A photograph (KSc) of an extralimital adult male north of Plattsmouth, Cass Co., 26 April, 2008 was filed. Accession # 1228

Chipping Sparrow (*Spizella passerina*)

1. Photographs (TL) of a single "wintering" bird in Lincoln, Lancaster Co. ; 06 January, 2008 were filed. Accession # 1212

Henslow's Sparrow (*Ammodramus henslowii*)

1. A photograph (TF) of "very cooperative singing" bird at Spring Creek

Prairie, Lancaster Co. ; 06 June, 2008 was filed. Accession # 1240

Lincoln's Sparrow (*Melospiza lincolni*)

1. A photograph (TL) of a single "wintering" bird in Lincoln, Lancaster Co. ; 06 January, 2008 was filed. Accession # 1211

Dark-eyed Junco (*Junco hyemalis*)

1. Multiple photographs (LH) of various plumaged birds near Lewellen, Garden Co., taken from November 2007 through February 2008 were filed. Accession # 1215

Northern Cardinal (*Cardinalis cardinalis*)

1. A description (LH) of a male and female bird observed near Lewellen, Garden Co. ; 30 November, 2007 and 20 February, 2008 was filed. Accession # 1216
